

- C. ORDINANCE M-2151/PARKING VARIANCE/A PLACE OF ZEN: Pass an ordinance granting a parking variance to allow the operation of A Place of Zen salon/spa located at 18360 Governors Highway.
- D. ORDINANCE MC-1043/AMENDING THE MUNICIPAL CODE/LIQUOR LICENSES: Pass an ordinance amending Section 10-58 of the Homewood Municipal Code increasing the number of available Class 14E Liquor Licenses from zero to one and grant a liquor license to DSLR, LLC., formerly, Copper Still Martini Bar and Lounge.

- B. <u>PRESENTATION/WATER TRANSMISSION MAIN PROJECT</u>: Representatives from Burns & McDonnell Engineering will give a presentation on the water transmission main project.
- C. <u>AGREEMENT/WAIVE COMPETITIVE BIDDING/CONSTRUCTION OF WATER TRANSMISSION MAIN AND BOOSTER PUMP STATION:</u> Consider a motion to waive competitive bidding and enter into an amended contract with Burns & McDonnell Engineering Company, Inc of Kansas City, MO to construct a new water transmission main and booster pump station for a total cost of \$11,670,475 contingent upon final contract approval by the Village Attorney.
